**“Recommending the Conduct of an Annual Convention of the
National Tripartite Industrial Peace Council”**

WHEREAS, it is the policy of the State to institutionalize tripartism in labor-management relations, with representatives from the government, employers, and workers, to serve as a continuing forum for tripartite advisement and consultation in encouraging reforms in government, empowering workers’ and employers’ organizations, enhancing their respective rights, attaining industrial peace, and improving productivity;¹

WHEREAS, the National Tripartite Industrial Peace Council (NTIPC) was established to serve as the main consultative body for tripartite advisement and consultative body for tripartite advisement and consultation among labor, employer and government sectors in the formulation, review and implementation of labor, employment and social policies at the national level;²

WHEREAS, several National Industry Tripartite Councils (National ITCs) were created as sub-committees of the NTIPC;³

WHEREAS, Regional Tripartite Industrial Peace Councils (RTIPCs) were also established in all regions nationwide as a sub-committees of the NTIPC;⁴

WHEREAS, the RTIPCs and their sub-committees and all National ITCs, having been integrated as sub-committees of the NTIPC, are being supervised by the NTIPC;⁵

WHEREAS, there is apparent disconnect between the RTIPCs and the NTIPC, particularly due to lack of full awareness by the RTIPCs as to the personalities and/or organisations composing the NTIPC, and the functions, operational aspect and activities, among others, of the NTIPC; and the NTIPC, being the supervisor of all RTIPCs and National ITCs, may also encounter the same concern;

WHEREAS, there is a necessity to address the said recurring concern in order to strengthen the institutional relationship and linkage of the NTIPC and the RTIPCs towards better understanding and alignment of the RTIPC members of their duties, responsibilities and functions as a social partners vis-à-vis the NTIPC agenda.

NOW THEREFORE, BE IT RESOLVED AS IT HEREBY RESOLVED THAT, we, the Regional Tripartite Industrial Peace Council-Northern Mindanao respectfully recommend that the National Tripartite Industrial Peace Council, through the Honorable Secretary of Labor and Employment as Chairman, call for the conduct of an Annual NTIPC Convention, with the members of all the Regional Tripartite Industrial Peace Councils nationwide as
